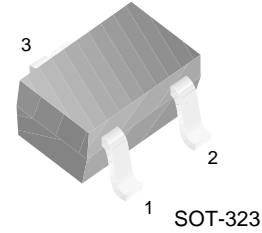

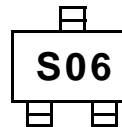

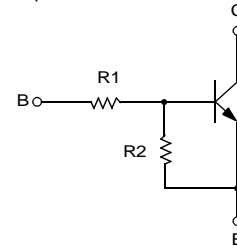


1. Base 2. Emitter 3. Collector

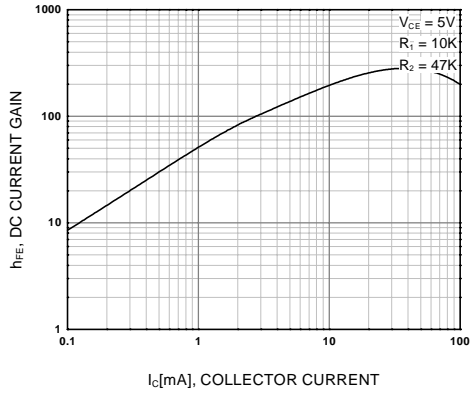


Figure 1. DC current Gain

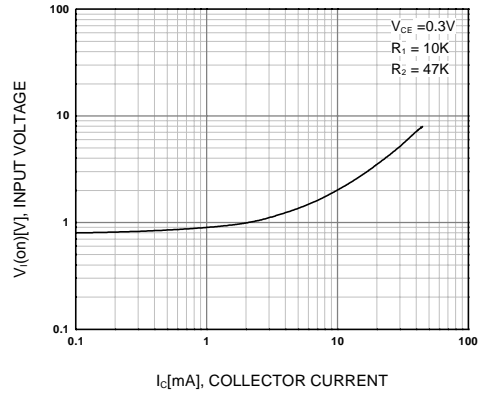


Figure 2. Input On Voltage

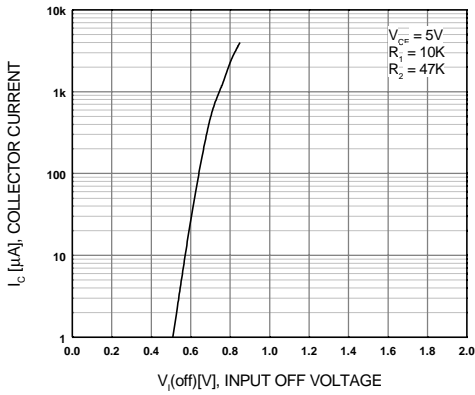


Figure 3. Input Off Voltage

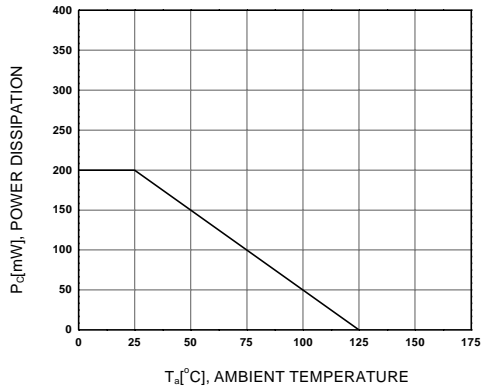
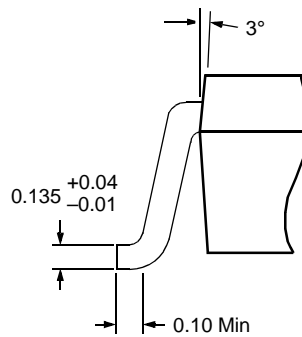
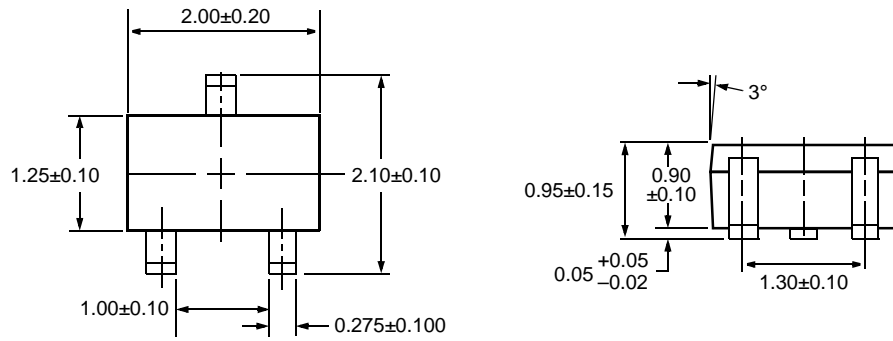


Figure 4. Power Derating
